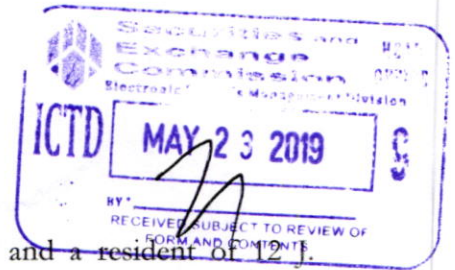


## CERTIFICATION
